

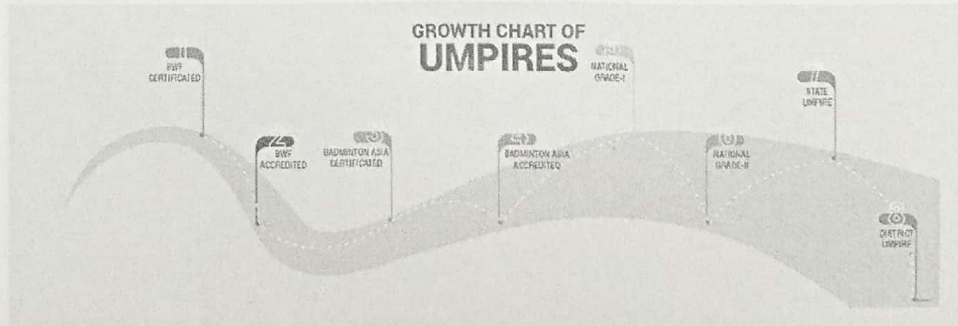

Norms for Technical Officials

1. Eligibility criteria for becoming a State umpire.
 - Minage24years&above
 - Should be graduate/diploma holder.
 - Should have average voice audibility & fluency in written & spoken English
 - Possess present able personality & must be physically fit.
 - Must have basic knowledge of computers
 - Must be familiar with badminton or should have played badminton.
 - Previous experience of officiating in district tournaments will be added advantage.
 - Should be passionate about officiating.
2. There shall be an Umpire Clinic for aspiring umpires every year in the month of March. Theory Classes and practical demonstration shall be conducted by BAI Qualified National Technical Officials followed theory examination. Practical assessment will be done during any of the state ranking tournaments. Candidates passing in both the theory and practical assessment will be inducted into the state panel.
3. The growth of a Umpire up to the international level is as follows.
 - District Umpire
 - State Certificated
 - National Grade-2
 - National Grade-1
 - Badminton Asia Accredited
 - Badminton Asia Certificated
 - BWF Accredited
 - BWF Certificated



4. There shall be pre-season refresher course for all state and national qualified technical officials every year in the month of March. It is mandatory for all the Technical officials to attend the Course to be eligible for assignments in the following season.
5. Selection of technical officials for up gradation will be based on their performance in tournaments (both on and off court) and selection examination. Merely attending more number of tournaments does not make one eligible for up gradation.



6. Technical official who do not officiate in minimum of four tournaments (three state ranking + one national ranking) organized by KBA, will be treated as inactive and has to undertake refresher course/test before being eligible for assignments.
7. Technical official officiating in tournaments not sanctioned by KBA shall intimate the same via mail in advance to KBA with tournament details before participating. Technical officials participating without intimation will be removed from the state panel and won't be considered for up gradation.
