SUBJECT: PLAYER ELIGIBILITY FOR SELECTION AND LIST OF PLAYERS QUALIFIED FOR THE FINAL SELECTION TRIALS FOR THE YONEX SUNRISE BWF WORLD JUNIOR CHAMPIONSHIP 2025 (GUWAHATI, ASSAM)– REG.

Dear All,

This is to inform you about the eligibility criteria for players aiming to be selected for the Indian team participating in the **YONEX SUNRISE BWF World Junior Championship 2025**, scheduled to be held in **Guwahati, Assam** - Team Championship from **6th to 11th October, 2025**, and Individual Championship from **13th to 19th October, 2025**.

The BAI Selection Committee (Juniors) has decided that the **ALL MEDALISTS** of the **WONDR Badminton Asia Junior Championships 2025** (Individual) **will receive direct entry into the Indian Team for the BWF World Junior Championships 2025**.

For the remaining spots in the Indian team, a **Selection Trial** will be conducted. **The criteria and details for this trial is mentioned below-**

- All players selected in the Indian Team for the WONDR Badminton Asia Junior Championships 2025** (Solo, Indonesia, 23rd–27th July 2025) will be invited for the trials, except the medalists.
- BAI Ranking:** Based on ranking points, as on 29th July 2025:
 - Singles Events – Top 8 players
 - All Doubles Events – Top 4 pairs
- BWF World Junior Ranking :** Indian Players in BWF World Junior Ranking Top 20 as on 29th July 2025
- BWF World Ranking (Sr.) :** All Indian Junior Players ranked within the Top 50 of the BWF World Rankings (Sr.) as on 29th July 2025

According to the above eligibility criteria, the list of players eligible to participate in the said Selection Trials is enclosed in **Annexure A**. All players are requested to send confirmation of participation through their State Association latest by Saturday 02/08/2025, 5pm on email: srsanjaymishra@gmail.com.

The Selection Trials will be conducted at the NCE, Guwahati from 9-13 August, 2025 and the matches will be played with AS50 Speed-2 Shuttlecocks.

NOTE: The Badminton Association of India (BAI) will avail the full player quota (as the championship is being hosted in India) for Indian participants in the YONEX-SUNRISE BWF World Junior Championships 2025. The details are as follows:

A. Team Event:

A maximum of 20 players (10 Boys + 10 Girls) will be selected for the team event. The final selection will be made by the coaches during the preparatory camp for the championship.

B. Individual Events:

India can field entries as per the following quota:

- **Men's Singles (MS):** 04 players
- **Women's Singles (WS):** 04 players
- **Men's Doubles (MD):** 03 pairs
- **Women's Doubles (WD):** 03 pairs
- **Mixed Doubles (XD):** 04 pairs
